

## **HEART OF AMERICA MODEL "A" FORD CLUB, INC. BYLAWS ADOPTION AND REVISIONS RECORD**

**ADOPTION** – These bylaws were approved and adopted by a unanimous vote of the Board present on December 2, 1969, and became effective January 1, 1970. These bylaws were approved by the 1969 Board, namely: Charles A. Smith, President- Al Patton, Treasurer-Russell Roberts, -Secretary Ralph Haggard, Past President-Bruce Adams, Assistant Technical Director-Opal Smallfield, Women's Activities Chairman-James Sams, Past President-William L. Adams, Editor-Jim Frazier, Vice-President-Tony Pace, Past President-Larry Dahmer, Technical Director

**REVIEW NUMBER ONE (1)** – These bylaws were revised November 19, 1976, by a committee appointed by the Board, namely: -Jim Frazier, Chairman -Barney Ankron -Tony Pace -Claude Chambers -Bill Dolinger -Dick McDougal

These bylaws were revised and approved by the 1977 Board and Club members at the membership meeting on March 20, 1977.

**REVIEW NUMBER TWO (2)** – These bylaws were revised April 28, 1981, by a committee appointed by the Board, namely: -Ray Nickelson, Chairman -Bud Butler -Milton Peck -Bob Hess -Ivan Wallen -Claude Chambers

These bylaws were revised and approved by the 1981 Board and Club members at the membership meeting on July 12, 1981.

**REVIEW NUMBER THREE (3)** – These bylaws were revised September 12, 1983, by a committee appointed by the Board, namely: -Bob Hess, Chairman -Scott Stuart -Ivan Wallen -John Stevenson -John Hargrave -Bud Butler

These bylaws were revised and approved by the 1983 Board and Club members at the membership meeting on October 28, 1983.

These bylaws were revised and approved by the 1992 Board and Club members at the membership meeting on November 16, 1992, and became effective January 1, 1993.

These bylaws were revised and accepted by the 1995 Board and Club members at the membership meeting on November 16, 1995, and became effective January 1, 1996.

These bylaws were accepted by the 1998 Board and Club members at the November 16, 1998, membership meeting. They became effective January 1, 1999.
